

# Gift Aid Form

Completing this form will cost you nothing but it will give Jewish Women's Aid an **additional 25p** for every pound you donate from now on, or have donated, in the past 4 years.

Under the Government's Gift Aid scheme, we are able to claim the tax back on every gift you make, as long as you are a UK taxpayer. So if your last donation was £100, it is worth £125 to us - **at no extra cost to you.**

Even if you are retired, you probably pay some form of tax. For example you pay tax on state or private pensions, state benefits, interest on savings and dividends. In fact it is very likely that we can claim back the tax on your donations, and it won't cost you a penny more.

So we would ask you to review your situation and if you are a taxpayer, to complete this form now and return it to us as soon as possible.
